My name is Stephanie and I have the privilege of serving as the President of Tulsans for Public Safety, Inc. We are a 501(c)3 non-profit, non-partisan organization comprised of Tulsa citizens with animal welfare background and experience, healthcare professionals, veterinary professionals, wildlife biologists, science-based professionals and property owners. While there are numerous public safety issues we care about as citizens who love and live in Tulsa, in this year's Candidate Questionnaire for Tulsa City Council Candidates, we are focusing on animal welfare and its relationship to public health and safety.

For the past two years, the City of Tulsa Animal Welfare Commission has been evaluating Tulsa's animal welfare issues, including a proposal to implement a Trap-Neuter-Release ("TNR") program regarding feral cats. The Commission has studied the issues and has not yet made a recommendation. They plan further analysis and discussion before doing so. Proponents of TNR also refer to "TNR" as "community cats", "cat colonies", etc. TNR means trapping, neutering, and releasing feral cats into public parks or neighborhoods. Feral cats expose the public to rabies and other serious diseases, including a deadly parasite uniquely attributable to cats, called "toxoplasmosis" that causes fetal death and profound congenital birth defects and is linked to neuropsychiatric and behavioral disorders.

We respectfully ask for your response to the attached survey. **The deadline is Saturday, August 20, 2022. We will text a downloadable link of your responses to voters of your district before Tuesday, August 23, 2022.** Please also note that while we are not eligible to endorse your campaign, individuals from our roster of 1,500 donors, activists, and supporters may. Your responses, or lack thereof, will be shared with our supporters. We appreciate your timely response.
